All contestants who participate in this event hereby expressly agree to by bound by the following rules and regulations:

## **Contestants Requirements**

- Contestants warrant that she is between 17-27 years of age, female by birth, of good health, of good moral character, single, never married, never divorced, never had a marriage annulled, not pregnant, and never given birth to a child.
- Contestants must be of 1/4 Asian decent
- Contestants warrant that she is not under contract with any person, firm or corporation that would prevent her appearance or participation in the Pacific Miss Asian American Beauty Pageant.
- Contestants agree that the contest judges' decisions on all matters relating to the Pacific Miss Asian American Beauty Pageant are final, absolute, and binding.
- Contestants consent and agree to unrestricted use by the Pacific Miss Asian American Beauty Pageant and its authorized representatives, advertisers, successor, sponsors, customers, and assigns of the name, pictures, likeness, voice, photographs, biographical information and statements for purposes of advertising, promotion and publicity in any and all media throughout the world in perpetuity without additional compensation, notification or permission, unless prohibited by law. Contestants also waive the right to inspect or approve such pictures, postings, advertising, videos used in connection thereof.
- All contestants in the 2013 Pacific Miss Asian American Beauty Pageant, agree to participate in the filming of the Miss Asian American Journey, a film that will document the full pageant contest, from the beginning of the pageant through to the end without compensation. Additionally, the winners of the Miss Asian American Beauty Pageant agree to be filmed as pageant winners and representative of PCI and the Miss Asian American Beauty Pageant without

compensation.

- Pacific Miss Asian American Beauty Pageant will have the exclusive right to arrange appearances and performances on radio, television, cable, internet, or other broadcast media by the Contestants for promoting the event.
- Contestants grant Pacific Culture International, the Pacific Miss Asian American Beauty Pageant, and its Agents the right to record any performance or public appearance by Contestants and reproduce, broadcast, or publish these events without compensation, unless prohibited by law. Contestants also waive the right to inspect or approve such pictures, advertising, videos used in connection thereof.
- Contestants understand and hereby agree that in the event she is crowned the winner, 1st Runner-Up, or 2nd Runner-Up, she will be required to sign a two-year contract with the Pacific Miss Asian American Beauty Pageant and she shall make herself available for all personal appearances at all scheduled events throughout her reign.   not compete/participate in any other beauty contest or pageant system for 12 months or until the title is relinquished to
  the new titleholder, unless authorized prior in writing by the Pacific Miss Asian American Beauty Pageant, whose
  decision shall be final and shall not be subject to any review, or appeal.
- Contestants agree to participate in a disciplined and diligent manner throughout the training program in accordance with the schedule of events that will be given to them and participate in all the rehearsals.
- Contestants agree to participate in all pageant related activities. Failure to participate will affect their pageant contest "Total Image" score.
- All prizes are subject to deduction of tax at source and all other taxes, as required by law.
- Contestants understand and agree that incorrect information will result in disqualification, whether discovered prior to, during, or after the finals and a candidate shall be liable to the Pacific Miss Asian American Beauty Pageant for such misrepresentations.
- The Pacific Miss Asian American Beauty Pageant is not responsible or liable in any manner whatsoever for nontelecast of the show, or noncompeting/non-occurrence of the event.
- Schedule of events and qualification rounds are subject to change at the absolute discretion of the organizers of the Pacific Miss Asian American Beauty Pageant.
- By participating, Contestants, their successors and representatives, hereby release and hold harmless the Pacific Miss Asian American Beauty Pageant and its organizers and sponsors and its affiliates, principals, directors, officers, employees and agents from any and all liability for any damages (including direct, special, consequential, exemplary or indirect damages), loss or injury of any kind, or claims based on publicity rights, defamation, or invasion of privacy, arising from or in connection with the Pacific Miss Asian American Beauty Pageant or any prize won, whether arising out of contract, warranty, negligence, strict liability in tort or otherwise.
